Membership Application Procedures

An Application Fee of \$500 must be submitted with the Membership Application. THIS FEE IS NON-REFUNDABLE. Submit applications to: Lexington Golf Club – Membership at P.O. Box 177, Lexington, Massachusetts 02420.

No candidate for membership will be considered until the Membership Application is completed, the candidate has read and affixed his or her signature to this page, and submitted the completed form and the Application Fee to the Club Secretary. The Membership Committee may request additional information from the candidate or his or her sponsors, and may conduct additional inquiries as necessary.

After an interview with the candidate, the Membership Committee will make a recommendation to the Board of Governors regarding the candidate’s membership. Membership approval is responsibility of the Board of Governors; two or more adverse votes from the Board of Governors shall result constitute denial of the application regardless of how many Board members are present for the vote. The Board shall have full power and discretion as to the election of members and shall not be bound in any way by the order in which the Membership Applications have been submitted. A lottery of all eligible candidates will determine the order of the waiting list.
